BETWEEN 0800 HOURS ON 9/23/01 AND 1700 HOURS ON 9/27/01 UNKNOWN SUSPECT(S) ENTERED JAMES ANDERSON'S RESIDENTIAL GARAGE AT 127 ANDREA ST, GOTHAM, BY FORCIBLY PULLING THE LEFT BOTTOM CORNER OF THE GARAGE DOOR TO GAIN ENTRY. ONCE INSIDE THE SUSPECT(S) REMOVED A TITAN 690GX COMMERCIAL PAINT SPRAYER (SERIAL #71900176) AND A TOOL BOX CONTAINING MISCELLANEOUS PAINTING EQUIPMENT. THE SUSPECT(S) EXITED THROUGH THE SAME LOCATION AS THEY ENTERED.

ANDERSON ESTIMATES THE TOTAL VALUE OF THE PROPERTY STOLEN AT \$3200.

THE SCENE WAS DUSTED FOR LATENT PRINTS, HOWEVER, NONE WERE OBTAINED.

TWO POLAROID PHOTOGRAPHS OF THE DAMAGE SUSTAINED TO THE GARAGE DOOR WERE IMPOUNDED AS EVIDENCE IN LOCKER #9 AT THE GOTHAM POLICE DEPARTMENT, 1234 E MAIN ST, GOTHAM.
