THE SUSPECT(S) THEN PROCEEDED TO THE REAR OFFICE WHERE THEY RANSACK A DESK. THE SUSPECT(S) THEN EXITED THROUGH THE BROKEN FRONT STORE WINDOW AS THE FRONT DOOR AND BACK DOORS REMAINED LOCKED.

# NARRATIVE

INCIDENT NUMBER: 01-132273

OFFICER:

ON 1/19/01 AT 0920 HOURS I WAS DISPATCHED TO 12048 BELT LINE HWY, GOTHAM, BRUEGGERS BAGELS, IN REFERENCE TO A COMMERCIAL BURGLARY. UPON MY ARRIVAL I CONTACTED THE OWNER AND COMPLAINANT, JOHN BRUEGGER. BRUEGGER RELATED FOLLOWING.

ON 01/19/01 AT 0845 HOURS BRUEGGER ARRIVED TO BRUEGGERS BAGELS, LOCATED AT, 12048 BELT LINE HWY, DISCOVERING THAT THE FRONT STORE WINDOW HAD BEEN BROKEN. HE UNLOCKED THE FRONT DOOR AND PROCEEDED INSIDE THE BUSINESS TO DISCOVER THAT THE CASH REGISTER DOOR HAD BEEN REMOVED FROM THE CASH REGISTER AND PLACED ATOP THE COUNTER. BRUEGGER INFORMED ME THAT THE CASH REGISTER WAS NOT LOCKED NOR CLOSED PRIOR TO HER LEAVING HER BUSINESS AT 1700 HOURS THE DAY PRIOR. BRUEGGER STATED THAT \$20 IN MISCELLANEOUS COINAGE WAS REMOVED FROM THE DRAWER.

BRUEGGER CONTINUED AND TOLD ME THAT THE SUSPECT(S) HAD ALSO RANSACKED THE DESK DRAWERS OF A DESK LOCATED IN THE OFFICE TO THE REAR OF THE STORE. I EXAMINED THE DESK AND NOTICED THAT THERE WERE MISCELLANEOUS PAPERS THROWN TO THE GROUND AND THAT SEVERAL OF THE DESK'S DRAWERS HAD BEEN OPENED. BRUEGGER SAID THAT NOTHING WAS MISSING FROM THE DESK OR OFFICE.

I THEN EXAMINED THE BROKEN WINDOW. THE WINDOW WAS 5 FEET WIDE BY 8 FEET TALL AND WAS BROKEN NEAR THE LOWER LEFT CORNER. THE BROKEN AREA MEASURED APPROXIMATELY 3 FEET TALL BY 2 FEET WIDE. TWO 4 INCH DIAMETER RIVER ROCKS WERE FOUND LAYING ON THE FLOOR WITHIN THE BUSINESS. THERE WAS A LARGE AMOUNT OF BROKEN GLASS ALSO WITHIN THE BUSINESS ON THE FLOOR. FIVE POLAROID PHOTOGRAPHS WERE TAKEN OF THE DAMAGE. THE POLAROID PICTURES WERE IMPOUNDED AT THE GOTHAM POLICE DEPARTMENT, 1234 E MAIN ST, GOTHAM, LOCKER #9.

I THEN DUSTED THE AREA FOR LATENT FINGERPRINTS. SEVERAL LATENT PRINTS WERE FOUND WITHIN THE BUSINESS NEAR THE INTERIOR PORTION OF THE DOOR FRAME BY THE DAMAGED WINDOW AND ON TOP OF THE REGISTER DRAWER. THE LATENT PRINTS WERE FORWARDED TO THE ID BUREAU FOR ANALYSIS.

BRUEGGER WAS GIVEN A VICTIMS RIGHTS PAMPHLET AND STATED THAT HE WOULD AID IN PROSECUTION.
